## **Gastroesophageal Reflux Disease (GERD)**

## **Assessment for Alarm Symptoms**

This measure is to be reported for all patients aged 18 years and older with GERD — a minimum of **once** per reporting period.

## Measure description

Percentage of patients aged 18 years and older with a diagnosis of GERD, seen for an initial evaluation, who were assessed for the presence or absence of the following alarm symptoms: involuntary weight loss, dysphagia, and GI bleeding

# What will you need to report for each patient with GERD for this measure?

If you select this measure for reporting, you will need to determine:

■ Whether or not the patient is being seen for an initial evaluation of GERD

If the patient is being seen for an initial evaluation of GERD, you will then need to report:

■ Whether or not you assessed alarm symptoms (involuntary weight loss, dysphagia, or gastrointestinal bleeding)

# What if this process or outcome of care is not appropriate for your patient?

There may be times when it is not appropriate to assess alarm symptoms, due to:

 Medical reasons (eg, not indicated, contraindicated, other medical reason)

In these cases, you will need to indicate that the medical reason applies, specify the reason on the worksheet and in the medical chart. The office/billing staff will then report a code with a modifier that represents these valid reasons (also called exclusions).

### **Coding Specifications**

Codes required to document patient has GERD and a visit occurred:

An ICD-9 diagnosis code for GERD and a CPT E/M service code are required to identify patients to be included in this measure.

### **GERD ICD-9 diagnosis codes**

- 530.81 (esophageal reflux),
- 530.10, 530.11, 530.12, 530.19 (esophagitis)

#### CPT E/M service codes

- 99201, 99202, 99203, 99204, 99205 (office new patient),
- 99212, 99213, 99214, 99215 (office established patient),
- 99241, 99242, 99243, 99244, 99245 (outpatient consult),

Quality codes for this measure (one of the following for every eligible patient):

#### **CPT II Code descriptors**

- *CPT II 1070F:* Alarm symptoms (involuntary weight loss, dysphagia, or gastrointestinal bleeding) assessed; none present
