

Reminder System for Mammogram

Coding Specifications

Codes required to document patient has undergone a screening mammogram:

An ICD-9-CM diagnosis code for screening mammogram and a CPT code or G-code are required to identify patients to be included in this measure.

All measure specific coding should be reported on the claim(s) representing the eligible encounter.

CPT code or G-code

- *CPT II 7025F:* Patient information entered into a reminder system with a target due date for the next mammogram
- *CPT II 7025F-8P:* Patient information not entered into a reminder system, reason not otherwise specified
