# **Bronchodilator Therapy**

## **Coding Specifications**

Codes required to document patient has chronic obstructive pulmonary disease (COPD) and a visit occurred:

A line item ICD-9-CM diagnosis code for COPD and a CPT E/M service code are required to identify patients to be included in this measure.

All measure-specific coding should be reported ON THE SAME CLAIM.

## COPD line item ICD-9-CM diagnosis codes

- 491.0, 491.1 (chronic bronchitis),
- 491.20, 491.21, 491.22 (obstructive chronic bronchitis),
- 491.8 (other chronic bronchitis),
- 491.9 (unspecified chronic bronchitis),
- 492.0, 492.8 (emphysema),
- 496 (chronic airway obstruction, not elsewhere classified)

#### AND

#### CPT E/M service codes

- 99201, 99202, 99203, 99204, 99205 (office-new patient),
- 99212, 99213, 99214, 99215 (office-established patient),
- 99241, 99242, 99243, 99244, 99245 (outpatient consult)

Quality codes for this measure:

### **CPT II Code descriptors**

(Data collection sheet should be used to determine appropriate code or combination of codes.)

- *CPT II 3025F*: Spirometry test results demonstrate FEV<sub>1</sub>/ FVC < 70% with COPD symptoms (e.g., dyspnea, cough/ sputum, wheezing)
- *CPT II 3027F:* Spirometry test results demonstrate  $FEV_1/FVC \ge 70\%$  or patient does not have COPD symptoms
- *CPT II* **3025***F***-8***P***:** Spirometry test results not performed or documented, reason not otherwise specified
- *CPT II 4025F*: Inhaled bronchodilator prescribed
- *CPT II 4025F-1P:* Documentation of medical reason(s) for not prescribing an inhaled bronchodilator
- *CPT II 4025F-2P:* Documentation of patient reason(s) for not prescribing an inhaled bronchodilator
- *CPT II 4025F–3P:* Documentation of system reason(s) for not prescribing an inhaled bronchodilator
- *CPT II 4025F-8P:* Inhaled bronchodilator not prescribed, reason not otherwise specified
